### Part II. Fireside Chat - Empowering women in creative industries (20 min):

Despite a higher number of females studying creative arts subjects, a smaller proportion of women transition into creative professions post-graduation. In Europe, merely one in five films is produced by a woman, and director roles are predominantly held by males. Moreover, within the creative industries, a significant portion of employment is through self-employment and freelance work. Eurostat data indicates that twice as many men are self-employed as compared to women. This discrepancy may stem from women's reluctance to pursue solopreneurship, often due to a lack of recognition, support, and social welfare backing. What should be implemented by policymakers and what can be the role of the industry to secure women's active participation and representation in the industry?
